

City of Lacombe
Bylaw 523

A Bylaw of the City of Lacombe, in the Province of Alberta (hereinafter referred to as “the Municipality”), to repeal inoperative, obsolete, expired, spent or otherwise ineffective Bylaws previously passed by the Municipality

WHEREAS, pursuant to the Municipal Government Act, R.S.A. 2000, c M-26, section 63(2)(b), a municipality shall repeal a Bylaw;

AND WHEREAS, the City of Lacombe wishes to repeal Bylaws that are inoperative, obsolete, expired, spent or otherwise ineffective;

NOW THEREFORE, the Council of the City of Lacombe, duly assembled, hereby enacts as follows:

1. BYLAW TITLE

1.1. The bylaw shall be referred to as the “Repeal of Inactive Bylaws 2025”.

2. REPEAL

2.1. The Bylaws listed on the attached Schedule “A” are hereby repealed.

2.2. Schedule “A” is attached and forms part of this bylaw.

3. EFFECTIVE DATE

3.1. This bylaw shall come into force and effect when it receives third reading and is duly signed.

4. SEVERABILITY

4.1. If any portion of this bylaw is declared invalid by a court of competent jurisdiction, then the invalid portion must be severed, and the remainder of the bylaw is deemed valid.
